

**“WHAT HAVE YOU DONE FOR YOUR MARRIAGE TODAY?”
2010 CONTEST RULES & PROCEDURES:**

- 1. This contest may be entered ONLY by callers to 361-289-6437, who leave their correct names, street addresses, and telephone numbers prior to leaving their comments on the radio station contest line.**
- 2. The contest will begin on January 11th, 2010 and conclude on February 12th, 2010 on Tom Lynn’s Morning Show (6 – 9 a.m.) when the winners’ names are drawn from all entries who called in their comments to the station, and whose information was stated in English, clearly enough for station personnel to understand.....**
- 3. Winner(s) names will be given on the air that day and then notified by telephone (our only way of notifying contestants) as soon as possible, and that notification call will be recorded for promotional on-air use by KLUX Radio.**
- 4. Immediate family members of employees or board members of Diocesan Telecommunications Corporation or KLUX Radio are ineligible.**
- 5. Lewd, vulgar or profane language in telephone calls will disqualify that caller from the contest. Decisions of the judges (KLUX management) are FINAL.**
- 6. A printed copy of these rules may be downloaded from the KLUX website (klux.org) or may be obtained in person at the studios of KLUX Radio, 1200 Lantana, Corpus Christi, TX, 78407. Copies will not be sent via mail or email.**
- 7. Callers who leave their comments in voice mail form on the contest line, are informed by an audio message prior to their recording, that their willingness to call and leave their comments carries with it their willingness for KLUX Radio to record and broadcast those comments. Telephone numbers and street addresses of callers will not be broadcast.**
- 8. - 9. All prizes must be claimed by the bonafide winner in person at our studio offices. Positive identification will be required. Any prize not claimed by March 14, 2010, will be considered forfeited by the winning contestant. NOTE: Some prizes may have an expiration date for pickup or redemption. Said dates will be well beyond the claiming deadline.**

10. Should a winner be unable to claim his/her prize in person, it is the responsibility of the winner to notify KLUX personnel by contact means given in item #8 (above), so that other arrangements may be made to get prize to winner.
11. KLUX is not responsible for incorrect contact information given by any contestant. KLUX personnel will attempt to make every reasonable method of contact in order to award any prize won to the proper winner. Our intent is to present any and all prizes won to appropriate winner(s).
12. Should any winner reject a prize or fail to be contacted, because of misinformation given to KLUX personnel, or other failure on winner(s) part, an alternate winner will be determined by random drawing at the KLUX studio/office complex.
13. All recordings of contestant voices become property of KLUX 89.5 H-D Radio, with no remuneration to individuals for broadcast.
14. Our hope is that all entrants in any of our contests, do so in good faith. We at KLUX 89.5 HD, present all contests in good faith, and fully intend to present all announced prizes to legitimate contest winners.
